##### Risk Governance

- Establish a culture within the Institution that emphasizes their commitment to internal controls, risk management and high ethical standards.
- Collaborate with cross functional teams including internal audit to ensure regulatory compliance and adherence to the best practices in risk management and update the risk matrix periodically.
- Review customer complaints and the process in place to resolve them, in order to mitigate the reputational risk for the brand.
